4a (Code: ) (Expenses \$ 356,338. including grants of \$ ) (Revenue \$ 90,569. ) IN 2021, SOUTHERN REINS PROVIDED SERVICES TO 110 UNIQUE INDIVIDUALS REPRESENTING 25 DIAGNOSES FROM 19 DIFFERENT MUNICIPALITIES IN THE GREATER MEMPHIS AREA. 52% OF PARTICIPANTS WERE MALE AND 48% FEMALE. 59% WERE UNDER THE AGE OF 18, AND 51% WERE 18 YEARS OF AGE OR OLDER. WE PROVIDED A TOTAL OF 1,779 LESSONS OVER THE COURSE OF 44 WEEKS OF LESSONS. ON AVERAGE, 25 GROUP AND PRIVATE LESSONS WERE INSTRUCTED EACH WEEK AT SOUTHERN REINS. WE SERVED 4 PARTICIPANTS IN WORKFORCE LEARNING, 13 VETERANS IN EQUINE SERVICES FOR HEROES, 22 INDIVIDUALS IN MAKING STRIDES RECREATION THERAPY, AND 71 CHILDREN AND ADULTS IN OUR ADAPTIVE RIDING PROGRAM. IN 2021 WE HAD THE SUPPORT OF 155 VOLUNTEERS WHO DONATED 6,375 HOURS OF SERVICE.
