SOUTHERN REINS CENTER FOR EQUINE THERAPY PROVIDED TRANSFORMATIVE EQUINE-ASSISTED SERVICES TO 259 INDIVIDUALS WITH DISABILITIES AND HARDSHIPS IN 2024 AND 337 TOTAL PARTICIPANTS WHEN INCLUDING OUR OUTREACH THROUGH PONY PALS. FROM AGES 3 TO 98, OUR PARTICIPANTS REPRESENTED 28 UNIQUE DIAGNOSES AND A DIVERSE COMMUNITY THAT WAS 47% FEMALE, 53% MALE, AND 4% ASIAN, 7% HISPANIC, 27% AFRICAN AMERICAN, AND 62% CAUCASIAN.
